

Terms of Use

Please read these terms carefully before using GiftWellSoon.

Effective Date: February 16, 2026

Welcome to GiftWellSoon! These Terms of Use (“Terms”) govern your access to and use of the GiftWellSoon platform, including when you create, manage, or share a registry (“Services”). By using our Services, you agree to these Terms.

01 Eligibility

- You must be at least 18 years old to create or manage an account and use our Services.
- Our platform is not intended for use by individuals under 18.
- A parent or legal guardian may create and manage a registry on behalf of a minor for whom they have legal authority to act.
- If you create a registry on behalf of another individual (including a minor), you represent and warrant that:
 - You have the legal authority to create and manage the registry on their behalf;
 - You have the authority to share their personal information, including any health-related information;
 - If you choose to make the registry public or searchable, you have the authority to do so.

Household & Responsible Party Ownership

- When a registry is created on behalf of a minor or dependent, the account holder is the sole responsible and accountable party for that registry, including all content, settings, and visibility decisions made in connection with it. No separate consent, confirmation, or approval from the minor is required to establish, manage, or modify the registry.
- For purposes of these Terms, a registry created by a parent, legal guardian, or authorized household member on behalf of a minor or dependent is treated as a single household registry. The account holder assumes all rights and obligations associated with the registry as if it were created on their own behalf.
- Email confirmation and account verification steps completed by the account holder are deemed sufficient to authorize the creation and management of a registry for any minor or dependent within their household. No additional verification step is required of or by the minor.
- By creating an account, you confirm that the information you provide is accurate and up to date.

02 Use of the Services

- You may use GiftWellSoon to create and share a personal registry for gifts, services, or support.
- You are responsible for all activity under your account and for maintaining the security of your login credentials.
- You agree not to use GiftWellSoon for any unlawful, fraudulent, or harmful purpose.

03 Registries and Content

- You are responsible for the content you post on your registry, including requests, updates, and personal stories.
- Registry content may include personal or health-related information that you choose to provide voluntarily.
- You represent and warrant that you have the right and authority to share any information you post, including information about another individual.

Content Responsibility for Minor & Dependent Registries

- When a registry is created on behalf of a minor or dependent, the account holder assumes full and sole responsibility for all content decisions made on the minor's behalf, including what personal or health-related information is disclosed, how the registry is described, and what support is requested. GiftWellSoon will look solely to the account holder with respect to any content posted in connection with such a registry.
- The account holder acknowledges that they have independently determined that sharing any personal or health-related information about a minor or dependent is appropriate, authorized, and consistent with applicable law. GiftWellSoon does not review or approve content posted on behalf of minors and assumes no responsibility for such content.
- GiftWellSoon is not subject to the Health Insurance Portability and Accountability Act (HIPAA).
- If you choose to share health-related or other sensitive information through the platform, you do so voluntarily. GiftWellSoon cannot guarantee the privacy or security of information that you choose to share publicly or with others.
- You agree not to post content that is offensive, misleading, infringing, or violates the rights of others.
- GiftWellSoon reserves the right (but is not obligated) to review, edit, or remove content that violates these Terms.

04 Donations, Purchases, and Third-Party Services

- Some items or services listed on registries may be fulfilled through third-party vendors or affiliates.
- GiftWellSoon does not process payments directly and is not responsible for any third-party transactions, delivery, or service fulfillment.
- Users should review and comply with the terms and policies of third-party providers when engaging with them.

05 Privacy

- Our Privacy Policy explains how we collect, use, and protect your information. By using GiftWellSoon, you agree to the terms of our Privacy Policy.

06 Intellectual Property

- All content and materials on GiftWellSoon (excluding your own registry content) are owned by or licensed to GiftWellSoon.
- You may not copy, distribute, or modify our materials without prior written permission.

07 Limitation of Liability

- GiftWellSoon is not responsible for any loss, damage, or disappointment arising from the use of our Services, including third-party transactions.
- Our Services are provided “as is” without warranties of any kind.

08 Offline Interactions and Scheduled Support

- GiftWellSoon is a coordination platform only. We do not provide transportation, childcare, medical care, or other in-person services.
- We do not screen, vet, supervise, or endorse any users or supporters who offer or provide help through the platform.
- Any in-person support arranged through GiftWellSoon is solely between the participating individuals.
- You assume all risks associated with offline or in-person interactions, including transportation, childcare, or other requested support.
